RULES & REGULATIONS

All policies are subject to change at any time without prior notice.

Below is an overview of guidelines and requirements for commonly used picnic locations. Please review carefully, as these details may impact your site selection and event planning.

A permit does not guarantee a reserved space. Most locations operate on a first-come, first-served basis, meaning a representative must arrive early to secure the desired area. While we assist with coordination, we cannot guarantee exact placement within a park or venue. Permit processing fees typically begin at \$100, depending on the location and timing of your event.

CITY OF SAN DIEGO & MISSION BAY

(Bonita Cove, Crown Point, De Anza Cove, Playa II, Ski Beach, Vacation Isle)

The following guidelines apply to Mission Bay and City of San Diego parks and are subject to change:

- Permits are issued on a first-come, first-served basis and must be paid in full at the time of application
 - Alcohol is currently prohibited at all Mission Bay and shoreline parks
 - A permit is required for groups of 50 or more guests attending a private event
 - Permit fees are non-transferable, changes incur a \$50 processing fee (must be made at least 15 days prior)
 - Refunds may be issued if canceled 60+ days in advance, minus applicable fees
 - Permit pricing varies by group size and does not include hourly usage fees
 - City parks may charge an hourly usage fee, including setup and breakdown time
 - Smaller groups may still require permits if using equipment such as canopies, inflatables, or seating setups
 - Certain parks restrict equipment like moon bounces, volleyball setups, and balloons
 - Balloons are not permitted in certain areas. Parks near the water in Mission Bay do not allow balloons
 - Amplified music requires special approval, while battery-operated sound systems are generally permitted
 - Glass containers are not allowed
 - Dog access and other restrictions vary by time and location

COUNTY PARKS

(El Monte Park, Felicita Park, San Dieguito Park)

County parks offer reserved spaces and additional amenities:

- Reservations are made for specific picnic areas and may include additional fees for equipment, catering, or early access
 - Parking is typically \$3 per vehicle, payable onsite or in advance by the client
 - Corporate reservations may be available with per-person pricing, which can include parking, catering, and equipment
 - Amplified sound is permitted only in designated areas. Megaphones and single-speaker systems may not be used for announcements.
 - Balloons are permitted in select areas only.
 - Pets are allowed on a leash
 - Cancellations within 60 days are non-refundable

MISCELLANEOUS CITY PARKS INFO

Carlsbad & Chula Vista Parks

(Aviara Park, Magee Park, Poinsettia Park, Stagecoach Park, Rohr Park)

- Reservations must be made at least 7 days in advance and up to 6 months prior
 - Smaller groups may use unreserved areas on a first-come basis
 - Inflatables are permitted in select areas only
 - Pets must be leashed at all times

Del Mar Parks

(Powerhouse Park, Seagrove Park)

- Permits are required for groups of 25+ or any catered/alcohol-served event
 - Permit pricing varies based on group size and location
 - Insurance may be required for catering and alcohol service

Lake Poway

- Parking fees apply, with different rates for residents and non-residents
 - Discounted parking passes may be available in advance
 - Cancellation fees vary based on timing

Santee Lakes

- Reservations require payment at the time of booking
 - Available on a first-come, first-served basis
 - Large groups may be required to reserve entire designated areas
 - Parking fees apply per vehicle

Each city and park system operates with its own permit process, pricing structure, and regulations. If you need more details about a specific location, our team is happy to assist.

Please note:

- Rules and fees may change at any time
- We cannot guarantee availability or policy consistency
- Permit applications do not guarantee space, they initiate the request process
